## RULES & REGULATIONS – Authority 491 – 11.5(4)

1. As used herein, "Terrible's Lakeside Casino" means Herbst Gaming, Inc. and any of its subsidiaries.
2. No purchase necessary to participate in promotion.
3. All participants must be 21 years of age or older.
4. Must have a player's card to participate. Player's cards are free and can be obtained at the Terrible's Lakeside Casino Guest Service Center located on the upper deck of the casino.
5. Entries and prizes are non-transferable and non-replaceable.
6. All winners must show their valid picture identification and their Terrible's Players Club card to claim their prize.
7. Employees and members of their immediate household (residing at same residence) of Terrible's Lakeside Casino are not eligible for this promotion.
8. Winner(s) is responsible for all federal, state and local taxes resulting from giveaway and fill out a substitute W-9 before receiving prize.
9. Terrible's Lakeside Casino will request written permission of the winner(s) to use name, photographs, etc for publicity and promotional purposes.
10. The interpretation of rules and eligibility are the sole discretion of Terrible's Lakeside Casino and IRGC. All decisions are final.
11. Terrible's Lakeside Casino reserves the right to modify this promotion at any time, for any reason, subject to all applicable regulatory approval, provided that such modification shall not, as of the date of such modification, materially alter or change any participants' prize previously won with approval of IRGC.
12. Terrible's Lakeside Casino reserves the right to disqualify a participant who attempts to alter entry forms or obtain entry forms outside the rules of the promotion.
13. Self-exclusions and persons that have been excluded from the property for any reason are not eligible to participate in this promotion. In the event a person should circumvent the rules of the promotion and be awarded a prize, the prize will be confiscated in accordance with the IRGC statues and regulations in place at the time the prizes are being awarded.
14. Any dispute not covered by the official rules will be resolved by Terrible's Lakeside Casino management employee(s), in a manner deemed by them, to be fairest to all concerned.

### Obtaining Entries

1. Registration is from 10am to 8pm every Monday and Wednesday (drawing day).
2. One (1) FREE entry/drawing day can be obtained by all Players Club members by showing their Players Club card and photo identification to the Guest Service representative.
3. Entries will be deposited into the clear acrylic designated drawing drum located at the Guest Service Center.
4. Guests may also earn bonus entries when using their Players Club card on slots and tables. One (1) entry for each 250 points earned on slots.
5. Earned slot entries will be based on points earned during promotional periods (bonus points do not apply).
6. Entries will be printed at the Terrible's Players Club. Must have Terrible's Players Club card.
7. Entries will be printed from the player's club system with their name and account number on the entry. All entry tickets must have valid date(s) and time(s) of the promotion to be eligible for each drawing.
8. If an entry form is drawn and does not have the valid promotion, time and date the entry will be disqualified.
9. Line to receive entries for promotion cuts off fifteen (15) minutes prior to drawing time, each drawing day.

### Format of Drawing

1. Total prize amount: \$500 in Points each drawing day.
2. Drawings will be at 8pm and winners will be announced throughout the casino at 8:30pm each drawing day. A sign with the winners will be posted at the Guest Service Center by noon the following day. (i.e. Monday drawing sign will be posted by noon on Tuesday).
3. 20 winners will each win \$25 in Points (5,000 points).
4. Winners may claim prize at the Guest Service Center after the 8:30pm announcement each drawing day or up to seven (7) days after drawing date.
5. Points will be loaded to each winner's player's club account when the prize is claimed.
6. Winners need not be present to win and will have seven (7) days to claim their prize.
7. If a winner does not claim his/her prize within the seven (7) day window he/she will forfeit their \$25 in points.
8. Valid photo identification is needed to claim prize.
